INCUMBENT WORKER TRAINING (IWT) GRANT FUNDING

The Incumbent Worker Training (IWT) program is a grant funding resource, helping to off-set a portion of skills-based training costs for incumbent (existing) workers employed by Montana's small business. Businesses must demonstrate training will increase the worker's skill-level, result in a promotion or wage gain, or expand their business market/increase business revenue, with the intent of preserving existing jobs for Montana residents. Small business is defined as private sector, for-profit and non-profits, operating year-round, with no more than 50 employees statewide.

USDA TO LAUNCH LOAN GUARANTEE INITIATIVE TO CREATE MORE AND BETTER MARKET OPPORTUNITIES

From American Association of Meat Processors (AAMP)

As part of the Administration's efforts to address food systems challenges arising from the pandemic as well as those going back decades, United States Department of Agriculture (USDA) Secretary Tom Vilsack today announced that USDA plans for another \$100 million in funding from the American Rescue Plan Act. The funding would leverage hundreds of millions more in lending through community and private sector lenders to expand meat and poultry processing capacity and finance other food supply chain infrastructure. These investments will help deliver more opportunities and fairer prices for farmers and address bottlenecks in the food supply chain <u>revealed and exacerbated</u> by the pandemic.

The Department plans to publish specific details on the new program and how to apply as part of USDA's <u>Build Back Better Initiative</u>, a comprehensive plan to invest \$4 billion to strengthen the resiliency of America's food supply chain while promoting competition.
